APPLICATION DEADLINES

To satisfy immigration and admissions requirements, international students should apply by the priority deadlines listed below:

- Fall (August-December) June 1
- Spring (January-May) October 1
- Summer (May-July) March 1

\$40 APPLICATION FEE

This is a nonrefundable, one-time fee to be paid after your application has been processed. Students will have the option to pay their application fee (in U.S. dollars) in one of the following ways AFTER their application has been processed:

*Actual documents required may vary from the above depending on student's status and program of interest.

DEGREE AND PROGRAM OPTIONS

Please note that admission to SPC does not guarantee admission to bachelor's degrees or limited access programs which require a separate application process.

These programs do not require English proficiency or transcripts:

• English for Academic Purposes

(fall and spring terms only) If English is not your primary language, our English for Academic Purposes (EAP) classes will bring your skills up to college level so you can succeed in your classes. Intensive English Program

(fall, spring and summer) This program is a more intensive program where students spend 22 hours per week engaged in the classroom and active learning, working their way from beginning to advanced levels. While this program does not earn college credit, once you have completed the advanced level, you can be admitted to SPC to pursue an academic degree. Accredited by the Commission of English Language Program Accreditation CEA. Associate in Arts (A.A.) degree takes about two years to complete and is designed to transfer to a bachelor's degree at a Florida public university or SPC. Along with classes to prepare you for your major at the four-year level, you also take at least 36 hours of general education classes.

Once you have earned your A.A. from SPC, you are guaranteed admission as a junior to one of Florida's public universities to pursue certain Bachelor of Arts or Bachelor of Science degrees. In Florida, this is called the 2+2 system, which allows you to pursue a bachelor's degree by first attending a state or community college and then transferring to a four-year institution. At SPC, you take the same general education courses you would take as a freshman and sophomore at a university, **but you get smaller classes and lower tuition costs** - about **50 percent less** than Florida's public universities.

FINANCIAL REQUIREMENTS

ST. PETERSBURG COLLEGE FINANCIAL SUPPORT INSTRUCTIONS

Each international student is expected to have sufficient funds to meet all personal and college expenses. St. Petersburg College requires you to have an equivalent yearly stipend (which is an estimate) to cover your anticipated academic and living expenses for a minimum of two terms.

• Financial requirement 1:

SPC requires you to complete a Statement of Financial Ability form found at: https://go.spcollege.edu/Central/IA/Forms/AS_Forms/Fillable_Version/AS_549. pdf with the appropriate signatures.

• Financial requirement 2:

Documents not in English must be accompanied by a certified English translation. Supporting documentation includes an **official bank statement or bank letter** dated no more than six months prior to the beginning of the semester you apply for. The financial document must be on official bank letterhead and include the account holder name, account type, current available balance for withdrawal and currency (if outside the U.S.). The current available balance for withdrawal must meet or exceed the estimated budget for the program you are applying for as indicated on the Statement of Financial Ability form. Bank letters must include an original signature by a bank official. All documents forwarded are held in strictest confidence.

- Bachelor's degree applicants must show proof of funds equal or greater to **\$26,338 USD***
- Associate degree and English for Academic Purposes applicants must show proof of funds equal or greater to **\$25,405 USD***
- Intensive English Program applicants must show proof of funds equal or greater to \$24,965 USD*
- * * Amount subject to change, please refer to the **Statement of Financial Ability form** located in Financial requirement 1 above.

If you plan to bring a dependent spouse or child on an F-2 status, an additional **\$5,000.00 USD** must be shown per dependent.

TRANSCRIPTS



FOR DEGREE-SEEKING APPLICANTS ONLY

Students must have earned a high school diploma (or equivalent) to be degree-seeking at St. Petersburg College (SPC). For students who earned education outside the United States, SPC requires an official (unopened) transcript evaluation by a current member of the National Association of Credential Evaluation Services (NACES). The NACES evaluation is required in place of international transcripts.



HIGH SCHOOL TRANSCRIPT REQUIREMENTS:

If your high school is within the United States, request that an official, sealed copy is sent to SPC after graduation.

If your high school is outside the United States*:

- Submit your official educational documents to a current NACES member after graduation – www.naces.org/members
- Request a general (document) evaluation
- The purpose of the evaluation (if asked) must reflect higher education, to study in the U.S. or something similar
- The official (unopened) NACES evaluation must be mailed or dropped off to St. Petersburg College

*In order to satisfy this degree-seeking requirement, the diploma earned outside the United States must be equivalent to a high school diploma in the United States. The NACES evaluation company will determine this information.

If you attended a college/university, please read below.

COLLEGE/UNIVERSITY TRANSCRIPT REQUIREMENTS:

If your college/university is within the United States, request that an official, sealed copy is sent to SPC.

If your college/university is outside the United States:

- Submit your official educational documents to a current NACES member – www.naces.org/members
- · Request a comprehensive (course-by-course) evaluation
- The purpose of the evaluation (if asked) must reflect higher education, to study in the U.S. or something similar
- The official (unopened) NACES evaluation must be mailed or dropped off to St. Petersburg College

IMMIGRATION DOCUMENTS



Documents must be readable and in good quality. All applicants must submit:

• Copy of valid passport (cannot be expired)

If you are currently in the United States, you will also need to submit:

- Copy of visa
- Copy of I-94 (You can find this form electronically by going to i94.cbp.dhs.gov)
- Copy of I-20 pages 1,2,3 (This is required for students currently on an F-1 or F-2 visa)
- Copy of DS-2019 (This is required for students currently on a J visa status)

ENGLISH PROFICIENCY

This is for degree-seeking applicants only. Students who are not proficient in English will first enroll in one of SPC's English language programs.

ACCEPTABLE PROOF OF ENGLISH PROFICIENCY

- 1. SAT/ACT scores dated within the last two years
 - 24 or higher on reading AND 25 or higher on Writing/Language subtests (SAT Redesign-Concordance)
 - 19 or higher on reading subtest AND 17 or higher on English subtest on Enhanced ACT
- 2. Applicable transfer coursework from a regionally accredited college/ university in the United States which qualifies you to take ENC 1101 (Composition I) or higher
- 3. St. Petersburg College's Placement Test
 - Students will be provided testing instructions after paying the application fee (\$40.00); The test is online and free.

UNABLE TO SUBMIT ENGLISH PROFICIENCY REQUIREMENTS?

If you cannot provide proof of English proficiency during the admissions process, SPC can issue a language training I-20 and you can take our placement tests free of charge upon arrival to the United States. Students whose placement scores meet the proficiency requirements can smoothly transition to a degree-program. If the placement test indicates a need for more language training, you will need to complete one of our English programs before pursuing a degree.





AFTER YOU ARRIVE IN THE U.S.

IMMIGRATION INFORMATION

Welcome! Now that you have arrived in the United States, it is important that you know, understand and follow the rules for study as an F-1 student. Check out Study in the States (**studyinthestates.dhs. gov/students**) resource from the U.S. Department of Homeland Security, to learn about government rules and important reminders for F-1 students studying in the United States.

St. Petersburg College (SPC) is authorized by federal law to enroll F-1 non-immigrant students. Our knowledgeable staff are here to help you maintain your F-1 status throughout your studies at SPC.

WHEN ARRIVING TO THE UNITED STATES, F-1 STUDENTS MUST:

CHECK-IN

You are required to check-in at the Center for International Programs (Clearwater or St. Petersburg/Gibbs campuses) as soon as possible, no later than the program start date printed on your I-20.

Bring the following items with you for check-in:

REGISTRATION

Each semester before registering for classes, F-1 students must submit the following items to the Center for International Programs:

- 1. Proof of health insurance
- 2. Health Insurance, Visit:

ACADEMIC ADVISING

Academic advising is available on every campus. Visit www. spcollege.edu/current-students/student-affairs/studentsupport-services/advising to learn more and schedule an appointment with an academic advisor. F-1 students are strongly advised to see an academic advisor every semester prior to registering for classes.

COURSE LOAD

F-1 students must be enrolled full-time:

- 12 credit hours required in Fall and Spring semesters
- 9 credit hours for Summer semester (if required)
- Online course credits:
 - Only 3 online credits may count toward full-time requirement each semester
 - F-1 students in an English language program may not count online courses toward full-time requirement

CONTACT

• F-1 regulations are **not negotiable**. If you are planning to, or already have dropped or withdrawn from a class, contact your International Advisor/Designated School Official (DSO) **immediately**.



While studying in the United States, it is important to maintain your F-1 student status. Maintaining your status means:

- Fulfilling the purpose for why the U.S. Department of State issued your visa (for example to get a college degree or study English).
- Following the regulations associated with that purpose.



TRAVEL WITH AN F-1 VISA



TRAVELING WITHIN THE UNITED STATES

You may travel freely within the United States during holidays and breaks. Always carry your identification documents.

TRAVELING OUTSIDE THE UNITED STATES

If you plan to travel outside the United States, contact the Center for International Programs for travel authorization.

Required documents to re-enter the United States:

- I-20 (signed for travel authorization)
- Valid F-1 visa
- Valid passport

You may leave the United States at times when classes are not in session (summer term, spring break and holiday break). Emergency travel needs to be discussed with your International Advisor (DSO).

If you entered the United States with another visa type and changed your status to F-1, you must obtain an F-1 visa from the U.S. Embassy/Consulate in your home country before reentering the United States.

Your passport must be valid for at least six months beyond your period of stay in the United States. You should contact your Consulate or Embassy in the United States about renewing your passport.

HOLIDAY AND VACATIONS

You may remain in the United States and will be considered to be maintaining lawful F-1 status during holidays and vacation periods observed by SPC. This includes annual summer vacations – if you are eligible. Please check with the Center for International Programs to determine eligibility for summer break. If you plan to leave the U.S. for vacation, check the dates on your I-20 to ensure that it won't expire and it is signed for travel.

ANNUAL SUMMER VACATION

SPC F-1 students may be eligible for annual summer vacation.

- Ask your International Advisor (DSO) if you have any questions about annual summer vacation eligibility.
- F-1 students are not permitted to take annual vacation break during fall or spring semesters.

Due to the covid-19 pandemic please check with the international office prior to making travel plans.

EMPLOYMENT BASICS

ON-CAMPUS EMPLOYMENT

Degree-seeking students who maintain F-1 status may apply for on-campus employment. You must contact the Center for International Programs to discuss work authorization before beginning any employment. On-campus employment is specific to work that takes place on campus. Examples of on-campus employment include **working at the college** labs, bookstore, cafeteria, gym, etc.

OFF-CAMPUS EMPLOYMENT

Economic Hardship employment is work that takes place outside of a school campus. Offcampus employment is only available to F-1 students who have completed at least one full academic year of their program of study, and who have an economic hardship that qualifies for the **Department of Homeland Security's emergent circumstances**. www.ice.gov/sevis employment#wcm-survey-target-id



EMPLOYMENT RELATED TO STUDIES

Practical training is work directly related to your major field of study. Some employment options require USCIS approval as well as recommendation from the Center for International Programs.

- Curricular Practical Training (CPT) An F-1 student may be authorized by their International Advisor (DSO) to participate in a curricular practical training program that is an integral part of an established curriculum.
- Pre-Completion Optional Practical Training (Pre-OPT – is part-time work before graduation. The use of Pre-completion OPT is deducted from the amount of time allotted for Post-Completion OPT.
- Post-Completion Optional Practical Training (Post-OPT) – is full-time work after graduation. You may apply 90 days before graduation or within 60 days following the last date of the semester in which you graduate.

TAXES

Federal Income Tax

The U.S. government requires a tax return to be filed for all money earned (employment and taxable scholarships). It is recommended that you obtain tax advice form a qualified tax expert. https://www.irs.gov/individuals/internationaltaxpayers/foreign-students-scholars-teachersresearchers-and-exchange-visitors

Social Security Tax

Contact your International Advisor for details. Employment authorization is a complicated procedure that requires a recommendation from your International Advisor.



UPON PROGRAM COMPLETION

PROGRAM COMPLETION

Once you complete your program of study and any authorized period of practical training, F-1 students have a 60-day grace period to:

- Change education level at SPC
- Transfer to a new school
- Depart the United States

CHANGING EDUCATION LEVEL

- F-1 students completing English language classes who plan to become degree-seeking:
- Visit the Center for International Programs at the beginning of your final semester of your English language program to discuss the transition
- Updated financial documents may be required and can be found at https://go.spcollege.edu/Central/IA/ Forms/AS_Forms/Fillable_Version/ AS_549.pdf
- Must have NACES evaluation of high school transcript on file www.naces.org/members

I-20 EXTENSION

The I-20 program date extension is intended for F-1 students who are not able to complete all degree requirements to graduate by the program end date listed on the I-20 Form. I-20 extension requests may be granted for the following reasons:

- Change of Major
- Medical Reason
- Unforeseen Circumstances

Delays caused by academic probation or suspensions are not an acceptable reason for program extension.

I-20 EXTENSION ELIGIBILITY GUIDELINES:

- Request I-20 extension at least 60 days before your current I-20 expiration date
- Extension requests can be granted only if the student is maintaining his/her status and making progress toward completing his/her educational objective
- Student must have continually maintained legal status
- You must submit an academic advising graduation check
- New Financial Support Documents are required
- Contact the Center for International Programs to request a program extension

TALK WITH YOUR DSO FIRST

If you are an F-1 student studying in the United States, your International Advisor (DSO) should be the first person you talk with if you have any questions regarding the legal requirements of your stay in the United States. Your DSO can assist in answering your questions or help you find someone who can help.


F-1 students should speak with their DSO if you are planning to do any of the following:

TRANSPORTATION

FREQUENTLY ASKED QUESTIONS

How do I apply to SPC as an international student?

Details on how to apply to SPC as an international student are covered in the first section of this guide.

Does SPC require proof of English proficiency to apply?

Proof of English proficiency is required for degreeseeking admission. International students who are unable to provide proof of English proficiency during the admissions process may request a languagetraining I-20 and take SPC's placement test upon arrival. If your English scores are not at college level, you will be referred to one of SPC's English as a Second Language programs: Intensive English Program (IEP) or English for Academic Purposes (EAP). Students scoring below a combined score of 85 on the LOEP are recommended to begin their studies at the IEP program.

Do international students need health insurance?

Yes. Health Insurance is required for International Students. Coverage must begin prior to your enrollment, and you are required to maintain the coverage during the time you are a student. https://blog.spcollege.edu/international/ health-insurance-required-international-students/

How do I know what classes to take for my English or degree program?

Your placement test will determine the classes for which you are eligible to enroll. An academic advisor can explain your placement test results and help you create an academic plan.

What happens if I don't attend my classes?

Refer to your course syllabus to determine each class attendance policy. If you exceed the acceptable absences, you may be withdrawn from your class. Students who drop below full-time are in violation of F-1 status.

How do I request the F-1 student visa?

- 1. Apply and complete admission to SPC
- 2. Receive Form I-20 (after admission)
- 3. Pay the I-901 SEVIS fee: www.fmjfee.com/i901fee/index.html
- 4. Find your nearest U.S. Embassy or Consulate: www.usembassy.gov/
- 5. Complete Form DS-160 Online: travel.state.gov/content/travel/en/us-visas/ study/student-visa.html

Important! Review the U.S. Embassy website for important information about requesting a visa in your country. **EducationUSA** is an excellent resource in-country and can let you know information that may be unique to your U.S. Embassy.

What happens if my passport expires?

Your passport must be valid for at least six months beyond your period of stay in the United States. You should contact your consulate or embassy in the United States about renewing your passport.

What happens if my visa expires?

As long as you stay in the United States and maintain your F-1 status, you do not need to renew your visa. You will need to renew an expired visa if you plan to depart the United States for any reason and want to return to the United States to continue your program of study. Students may renew their visas at any time, as long as they have maintained student status and their SEVIS records are current. Continuing students may enter the United States at any time before their classes start. Visit **travel.state.gov/content/travel/en/us-visas/study/student-visa. html** to learn more.

What do I do if my passport is lost or stolen?
