Student success is the central focus of St. Petersburg College (SPC), which was founded in 1927 as St. Petersburg Junior College, Florida's first two-year institution of higher education. Today the college stands as a multi-campus four-year public institution with 10 learning sites throughout Pinellas County, home to a million residents. SPC serves more than 49,000 students each year, awarding more than 6,000 degrees and certificates, and was the first state college to offer bachelor's degrees (25 in across the academic disciplines and workforce needs).

SPC is presently the largest provider of online education in the Florida College System (FCS); approximately 10% of all the online education offered through the 28 community colleges is offered by SPC. For SPC, online courses at the associate's, bachelors, and certificate level comprise 30% of overall enrolment in fall and spring semesters and more than 50% in summer.
