1. History and Characteristics

St. Petersburg College (SPC) was founded in 1927, opening as Florida's first two-year institution of higher learning serving Pinellas County under the name St. Petersburg Junior College (SPJC). SPJC was chartered by the State of Florida in 1928; graduated its first class in 1929; located to its own first campus at Mirror Lake in 1931; and was initially accredited by the Southern Association of Colleges and Schools in 1931. In 1948 it converted from private, non-profit to public status, and in 2001 it was renamed St. Petersburg College when it was authorized by the Florida Legislature, the College District Board of Trustees, and the Southern Association of Colleges and Schools Commission on Colleges to offer baccalaureate programs under a 2 + 2 model. SPC employs an open-door admission policy with some entry requirements for specialized programs. SPC is governed by a five-member Board of Trustees appointed by the Governor of the State of Florida. SPC is one of 28 colleges within the Florida College System; the other 27 institutions would be considered peer institutions for comparison. Geographically, Hillsborough Community College is the closest peer institution, with Valencia College and Palm Beach State College the most similar in demographic makeup and student population size. Additional peer colleges include Broward College, Florida State College-Jacksonville, and Miami Dade College.

SPC enrolled approximately 36,137 students (credit and non-credit) students in AY 2021-22, primarily from the College's geographic service area of Pinellas County, Florida. Of students enrolled in a program, approximately 35.1% were seeking the Associate in Arts degree; 15.2% were seeking a Baccalaureate degree or Professional Certificate; 29.7% were seeking an Associate in Science degree, Advanced Technical Diploma, or workforce certificate; and 20.0% were undeclared. The college serves a broad range of ages, with 56.3% falling under the age of 25 years in Fall 2021. Women are in the majority, making up 61% of the student body. In so far as ethnicity, 58.4% of students list their ethnicity as "White," 12.6% of students identify as African-American, and 17.1% identify as Hispanic.

Dr. Tonjua Williams began her service as SPC's seventh president in July 2017. In 2018, the Board of Trustees (BOT) revised the College mission statement to "empower our students and community to achieve success and economic mobility through academic excellence and engagement," and promote the values of student success, equity, integrity, community focus, growth and empowerment, and communication.

5. Accreditation

In addition to the accreditation that the institution holds with the Southern Association of Colleges and Schools Commission on Colleges, there are twenty-one active programs at St. Petersburg College (SPC) that are currently accredited or approved by federally recognized accrediting agencies. Each agency is recognized by one or more of the following bodies: U.S. Department of Education (USDE), Council for Higher Education Accreditation (CHEA), and the Association for Specialized and Professional Accreditors (ASPA). To date, each program has been granted full accreditation or approval status. No negative action has been taken against SPC for any accreditation or approval that the institution holds, and there have been no instances where an accrediting agency has terminated the accreditation of an SPC program as a result of non-compliance. SACSCOC is also the primary accreditor for Title IV funding.

Since the submission of the College's ten-year reaffirmation report to SACSCOC, SPC has voluntarily placed five programs with programmatic accreditation in teach-out status – the Orthotics & Prosthetics Associate in Science (ORTHO-AS) program and the Paramedic Advanced Technical Diploma (PMED-ATD), both accredited by CAAHEP; and three College of Education programs: the Science Teacher Education Biology 6-12 Bachelor of Science (BSCED-BS) program, the Middle Grades Science Education Bachelor of Science (MGSED-BS) program, and the Middle Grades Math Education Bachelor of Science (MGMED-BS). All three were accredited by the Florida Department of Education (FLDOE). Both CAAHEP and FLDOE remain accreditors for other SPC programs, and therefore the College has not withdrawn fully from these accreditors.
